- V.** Organization of Agenda and Declaration of Interests

- VI.** APCO Report

Terry Dressler, APCO, introduced new CAC member Ralph Baxter, who has replaced John Robinson on the council. Mr. Dressler also informed the CAC that the Environmental Protection Agency petitioned the judge to delay the new Federal Ozone Standard promulgation to July, 2011. It is not yet known if the judge will approve the delay. Staff will keep the CAC informed as they learn more.

**VII.** New Business

A. Discuss and consider recommending that the APCD Board of Directors implement amendments to four rules and the adoption of one new rule as follows:

1. Amended Rule 102, Definitions,
2. Amended Rule 201, Permits Required,
3. Amended Rule 370, Potential to Emit – Limitations for Part 70 Sources,
4. New Rule 810, Federal Prevention of Signification Deterioration (PSD), and
5. Amended Rule 1301, Part 70 Operating Permits – General Information.

Brian Shafritz of the APCD gave an overview of the purpose of the rule updates. Douglas Grapple explained that the rule materials the CAC received in advance of the meeting had since been modified by APCD staff, and handed out revised rules to the CAC. He also noted that Rule 202 was now included in the rulemaking action in place of Rule 201. Mr. Grapple then reviewed each of the rule changes.

A motion was made to recommend that the APCD Board adopt Amended Rule 102, Amended Rule 202, Amended Rule 370, New Rule 810, and Amended Rule 1301.
