  - iii) **Find that the transportation control measures approved by the Association of Governments as part of the RTP meet the emission reduction objectives established by the District for the attainment and maintenance of the state ozone standard;**
  - iv) **Adopt the California Environmental Quality Act Findings (Attachment 3);**
  - v) **Adopt the 2010 Clean Air Plan as submitted to your Board on December 16, 2010 and modified as set forth in Attachment 4; and**
  - vi) **Authorize the Chair to sign the attached letter (Attachment 5) transmitting the 2010 Clean Air Plan to the California Air Resources Board.**
