

RULE 210 AND RULE 213 FEES FOR FISCAL YEAR 2023-2024

July 1, 2023

In accordance with the provisions of Santa Barbara County Air Pollution Control District (District) Rule 210.V.C and Rule 213.C, the Air Pollution Control Officer performed annual fee adjustments based on the California Consumer Price Index (CPI) changes. For Fiscal Year 2023-2024, the adjustments resulted in a total CPI increase of 7.7%. All fees invoiced on and after July 1, 2023 are subject to the CPI adjustments and the updated values are reflected in the attached tables for Rule 210 and Rule 213.




